**Site Artist:** Resides within the studio tour boundaries (**west:** White's Road, **east:** Lakeridge Road, **south:** Lake Ontario, **north:** Goodwood Road). Participates actively in at least one of the organizing committees of the tour. The studio and exhibition space must be the artist's own residence or studio.

**Local Guest Artist:** Resides within the tour boundaries and hosted by a site artist. Participates actively in at least one of the organizing committees of the tour. Preference will be given for Local Guest Artists over Outside Guest Artists.

**Outside Guest Artist:** Resides outside of the tour boundaries and hosted by a site artist; not expected to serve on a committee, but help would be greatly appreciated.

All artists will be required to promote the tour by distributing at least 100 brochures and 300 bookmarks and other promotion as needed.

**Please submit the following information on CD ROM DISC.** (CDs will not be returned.)

1. Artist's Statement (one paragraph)
2. CV that includes your most recent awards, shows or exhibitions (past four years)
3. Six (6) digital images of your work showing all the different media or types of artwork that you request to display. The jury will judge each type of art separately for each artist. Minimum size: 1600 x 1200 pixels per inch. This is about a 5" x 4" Print at 300 dpi. If you are sending a 72 pixels per inch picture, or 72 dpi, the image needs to be in focus at about 2000 pixels on the long side and 1500 pixels on the short side. It will be a large image but it insures better quality. Please set your camera to its highest resolution setting to take your pictures, and send the pictures in JPEG format. Keep the background simple for 3-D work.
4. Include a description document that identifies each image in thumbnail and title: specifying medium, size, year produced and retail value. The titles of the images on the CD must match the titles on the document.
5. Short description of you and/or your artwork for brochure and web site, 25 words max.

In addition to the **application** and **CD**, please include **two cheques**, one for \$15 Jury Fee (non-refundable) and one for \$125 or \$150 Artist Fee, payable to "WILD AT HEART STUDIO TOUR" (returned if your application is not successful). Also bring a **small sample of your work** for the jurying.

**DELIVER** all application material to Martha Brown, 834 Naroch Blvd., Pickering, between Monday, Sept. 19<sup>th</sup> and Friday, Sept. 23<sup>rd</sup>. Call to arrange your delivery: 905-837-5540. Artists will be contacted by the jury committee via email by Oct. 1<sup>st</sup>. The artists can call to arrange pick-up of their work on Oct. 2<sup>nd</sup> or 3<sup>rd</sup>, day or evening.

**Agreement:** I, the undersigned, meet the criteria for the Artist Category I have selected and agree to the following:

I will display and sell only my own artwork and reproductions thereof during the Tour. All artwork will be of my own original design. I am responsible for insurance of my artwork. If a Site Artist, I will provide liability insurance for my site and assume responsibility for all artwork displayed on my site during the Tour. I understand that the organizers are not responsible for any loss, damage or injury that results from the Tour.
